Pathways for Philanthropy

KZCF provides several opportunities to partner and make an impact in your community! By establishing one of the following funds, you can ensure that your gift keeps on giving for generations to come.

- ✔ Love Where You Live Funds are community resources that are pooled together and invested to address the greatest needs facing our community at any given time. More information on these funds can be found on page nine.
- ▼ Field-of-Interest Funds enable donors to focus their giving on the community needs they care about most, such as youth, the environment, education, healthcare or the arts. Donors know their gifts will remain relevant and flexible to meet community needs in their area of interest. Our staff reviews and evaluates requests from the field and determines the best, most impactful grantmaking response.
- ▼ Donor Advised Funds (DAFs) are convenient, flexible tools for individuals, families, businesses or groups that want to be actively involved in suggesting community investments (grants) made possible by their fund.

- ▼ Nonprofit Funds are investment tools designed to support a specific nonprofit, educational institution or faith-based organization. These funds support an organization's financial goals and help with long-term sustainability and growth.
- Scholarship Funds support undergraduate and graduate education, training, professional development and other educational enrichment opportunities for individual learners.

You may also support an existing fund. With hundreds of funds to choose from, there might already be a pathway to philanthropy that is perfectly aligned with your values!

Donate appreciated stocks, bonds or mutual funds.

If you currently hold these types of funds in a taxable brokerage account that has increased in value since you acquired them, this is one of the best ways to donate. When you donate these assets directly to KZCF, you avoid paying capital gains taxes on the appreciation and you get a tax deduction for the full value of the securities.

Donate from a DAF.

It is easy to support your community with a gift from a DAF, whether it is held here at KZCF or elsewhere!

Give tangible personal property (real estate, art, vehicles, collectibles, etc.).

KZCF has professional staff and advisors to help you leverage more complex assets to achieve your philanthropic goals!







By donating directly from your IRA to KZCF through a Qualified Charitable Distribution, you can avoid tax liability and make an impact in your community! Simply contact your IRA provider and request a direct transfer to KZCF.
