Kalamazoo Community Foundation (KZCF) offers Donor Advised Funds (DAFs) as a tax-advantaged tool for individuals who wish to actively participate in giving to a variety of nonprofit organizations and causes.

Anyone can start a DAF with any gift amount. The DAF will become active once the fund balance reaches \$5,000. Like our other funds, these DAFs are invested to grow. We know individuals, families and organizations have many choices regarding where to open a DAF. Here is why you might choose KZCF.

## Our returns are competitive.

Compared to the most popular commercial sponsors of DAFs, KZCF offers excellent returns on your investment. Our 10-year return (net of all fees) was 6.7% for our non-endowed DAFs compared to 4.41% and 4.60% for comparable offerings at Fidelity Charitable and Vanguard Charitable, respectively. Better returns mean more money available for your grantmaking.

### We are available for you.

If you are savvy with a computer, we offer a donor portal that allows you to be self-sufficient in suggesting grants and monitoring your fund. For the times when you really need someone on the other end of the telephone — or at the opposite end of the table — we are available.
